III. CSUSA REPORTS

School Presentation

- Amber Jensen, Principal at Gateway Intermediate High Charter School introduced the board to three students enrolled in their Cambridge Program at the school and they each expressed their feelings about the program and the school itself.
- Thomas Martin (student), shared with the board how he is enrolled in the FECU Program from Cambridge, and his experience has been outstanding. He mentioned that teachers gain a personal connection with the students in the classroom, and they feel like part of a family. It has also prepared him for college life, and he has learned responsibility and how to manage time effectively. He is engaging in the medical field and hopes to be a doctor one day.
- Pily Leon (student), shared with the board that when she started at the school in 8th grade, at first, she was extremely nervous since she had just come from Columbia, and she never thought she could get into an exclusive program like Cambridge. She thanked one of her teachers who encouraged her to apply. She got in and now has even received the honor of a granted scholarship. She appreciates the one on one with all her teachers. She plans to attend the University of South Florida in Tampa and engage in international business marketing, and plans to graduate in the year 2025, which is much faster.
- Bailey Siglage (student), a senior in the school who started in 4th grade, quickly realized
 the drastic difference from middle to high school. She quickly learned how to manage
 deadlines, which will help her in the future to perform satisfactorily.
- Principal Jensen shared with the board that this school is the only high school in Lee County which offers a Cambridge diploma by 2nd year in school. Staff meet with students on a one-on-one basis to coordinate their classes. They are provided with a white jacket and when they demonstrate they have passed the Cambridge Exam they have their name placed on a plaque on the wall. The number of students keeps increasing every year. Board Member Pat Smith thanked and congratulated them.

State Director Report

- Chief of Schools, Dr. David Christiansen thanked Principal Amber Jensen and the staff at Gateway Charter High School for their work with the children. Dr. Christiansen reported out the agenda for the Mid-Year review and meeting.
- Dr. Eddie Ruiz updated the board that Gateway Charter High School had the best graduation ceremony in the network and thanked Principal Jensen for her mindset and successful Cambridge Program.
- Dr. Ruiz updated the board on the Innovation Pilot Program that several schools are participating in and outlined the parameters of the program.
