I. PUBLIC COMMENTS

- Suzanne Brown parent at Lakewood Ranch Preparatory has Kindergartener there and at the
 previous board meeting discussed teacher retention and is upset that son's favorite teacher
 resigned. Several issues at the school are still happening and parents are expressing their
 concern with each other, and teachers are also sharing their concerns with parents. Mrs. Brown
 would like to see Kindergarteners reach high school in the same school. Ms. Brown commended
 the Leadership in the school that is doing their best to deal with this situation.
- Chris Brown spouse of previous public speaker and wanted to also share concern that there has been teacher turnover at the school regardless of the great job that Leaders Warren and Cendan are doing. Mr. Brown would like problems identified at the school and what is being done about it. Currently in the process of deciding whether their child should stay in school or not.

Fall Testing Results - Tier 3 Updates

• The board reviewed the NWEA fall assessment data as well as the PM1 FAST dashboards. Dr. Meredith Ross and Dr. Eddie Ruiz met with board member Billie Miller to review in depth the data points and explained to the board that the fall results establish a baseline to monitor the students' results. The winter testing window has just opened and a comparison of Fall to Winter will be presented at the February board meetings.
